EVOLUTION VS. CHRISTIAN STEWARDSHIP

The Glorification of God as Creator

Christian Stewardship begins with the premise that God is the Creator and Owner of all things. The responsibility of mankind is to manage His things according to His will for His glory. Christian stewards endeavor to be caring, careful caretakers of themselves and whatever else surrounds them in love for God.

Defined, Christian stewardship is the free and joyous activity of the child of God and God's family, the Church, in managing all of life and life's resources for God's purposes.

For a Christian, the glorification of God is the primary purpose of existence. The stewardship of "God-glorification" is all inclusive, involving God pleasing management of oneself, one's possessions, the Church, the environment, personal activities, as well as other people. "Like good stewards of the manifold grace of God, serve one another with whatever gift each of you has received." (1 Peter 4:10) "So whether you eat or drink or whatever you do, do it all for the glory of God." (1 Cor. 10:3)

Nov. 24, 2009 marks the 150th anniversary of Charles Darwin's book, "The Origin of Species" and the Theory of Evolution.

The Theory of Evolution rejects the concept of God as Creator. The theory assumes higher forms of life evolved from lower ones via mutations and natural selection. It proposes change over a long period of time and assumes that life somehow originated and advanced without divine intervention. The theory negates the concept of God as Creator/Owner of all things. Evolutionary stewardship of the world, as a result, ends up humanistic.

Evolution - An Unproven Theory

It should be understood and stressed that evolution is still a theory, a hypothesis which has not been established as scientific fact. Modern science functions on the basis of the "Scientific Method" proposed by the 16th century philosopher, Francis Bacon.

The method, very effective in the pursuit of knowledge and progress, has three parts:

- 1. HYPOTHESIS A theoretical statement (guess) regarding something in nature.
- 2. OBSERVATION Testing the hypothesis (theory) through experiments.
- 3. CONCLUSION Establishing proof for the hypothesis as scientific fact.

To date, the evolutionary hypothesis is still in the realm of observation (stage 2) and has not been established as scientific fact.

Observation Complications

Some scientific observations oppose the theory. For example, a gradual evolutionary progression of life from very simple forms to higher forms is not conclusively found in fossils. Furthermore, genetic mutations have not produced new gene forms that would enable a new race of organisms to evolve. Actually, mutations produce weaker organisms, not stronger ones. Again, "Symbiosis" (the scientific fact that life depends upon life to exist) negates the evolutionary assumption that life evolved over a long period of time. For example, coral, algae and fish on an ocean reef depend on each other to exist. To separate their origin by long periods of time is scientifically unreasonable. The fact of symbiotic dependancy for life to exist favors a quick creation-the Biblical six days of Genesis 1 & 2.

- 09-01: SELC Foundation established. Affirmed the Board of Directors action in establishing a foundation. Congregations to make known to members the opportunity to continue to support the work of the Lord through contributions to the Foundation.
- 09-02: Official remembrance and recognition of Rev. Dr. Jaroslav (Jary) Jan Vajda and his outstanding contributions to the SELC District and to the Church.
- 09-03: Continue funding the position of Gift Planning Counselor in partnership with Lutheran Haven for three years.
- 09-04: Commending Robin Paris for her work as Gift Planning Counselor for Lutheran Haven and the SELC District.
- 09-05: Encourage congregations to continue their commitment to outreach and to use SELC congregational grants in new and creative ministries for the advancement of the Gospel.
- 09-06: Compliments to Concordia University for the excellent facilities and services provided to the delegates and guests.
- 09-07: Request of the SELC Board of Directions to reconsider the composition of the SELC Foundation Board.
- 09-08: Offerings of the 2009 SELC District Convention devoted to the SELC Foundation.
- 09-09: Added a 3rd Vice President to the SELC so that each circuit is represented in the SELC Presidium.
- 09-10: Request that the BRTFSSG correct their report on non-geographical district which has been disseminated throughout the Synod and that this correction to be disseminated to all Districts and in all existing media.
- 09-11: Request to the BRTFSSG to revisit the idea that Synodical/District restructuring to include the consideration of the formation of smaller districts.
- 09-12: Any redistricting plans considered by the Lutheran Church Missouri Synod that would eliminate non-geographical districts abide by the 1969 merger agreement with the SELC; that the Blue Ribbon Task Force on Structure and Governance consult the legal opinion contained in the memo from the SELC District to the previous Taskforce on National/District Relations, dated No. 1, 2000; that the Lutheran Church Missouri Synod abide by the terms of the 1969 merger agreement; specifically, that no decision to eliminate the SELC district be made without the concurrence of that district. Referred to the SELC Board of Directors to investigate and communicate in appropriate ways.
- 09-13: The SELC District thanks the task force for work to date; strongly encourage the task force to proceed with care, patience, and transparency. The SELC District commits to pray for the task force and pray for a resolution of the structuring issues at LCMS Convention. Pastors and lay delegates to the SELC District Convention encouraged to convey their individual concerns in writing to the task force.

The following is a letter from Dr. Gerald B. Kieschnick, President of The Lutheran Church - Missouri Synod:

Dear Brothers in Christ:

Grace and peace be with you, from God our Father and from our Lord and Savior, Jesus Christ!

As communicated in a previous statement from my office, on Friday, August 21, the Churchwide Assembly of the Evangelical Lutheran Church in America voted to open the ministry of the ELCA to gay and lesbian pastors and other professional workers living in "committed relationships." In an earlier action, the assembly approved a resolution that commits the ELCA "to finding ways to allow congregations that choose to do so to recognize, support, and hold publicly accountable life-long, monogamous, same-gender relationships."

The Lutheran Church—Missouri Synod has repeatedly affirmed as its own position the historical understanding of the Christian church that the Bible condemns homosexual behavior as "intrinsically sinful." Such behavior is therefore contrary to the will of the Creator and constitutes sin against the commandments of God (Lev. 18:22, 24, 20:13; 1 Cor. 6:9-20; 1 Tim 1:9-10; and Rom. 1:26, 27).

Addressing the ELCA assembly on Saturday, August 22, I responded to their aforementioned actions, stating: "The decisions by this assembly to grant non-celibate homosexual ministers the privilege of serving as rostered leaders in the ELCA and the affirmation of same-gender unions as pleasing to God will undoubtedly cause additional stress and disharmony within the ELCA. It will also negatively affect the relationships between our two church bodies. The current division between our churches threatens to become a chasm. This grieves my heart and the hearts of all in the ELCA, the LCMS, and other Christian church bodies throughout the world who do not see these decisions as compatible with the Word of God, or in agreement with the consensus of 2,000 years of Christian theological affirmation regarding what Scripture teaches about human sexuality. Simply stated, this matter is fundamentally related to significant differences in how we [our two church bodies] understand the authority of Holy Scripture and the interpretation of God's revealed and infallible Word." The "relationships" to which I referred have been addressed by resolutions adopted at the last three LCMS national Synod conventions:

! Resolution 3-21A of the 2001 convention (complete text—page 142, 2001 Convention *Proceedings*) resolved that we cannot consider the ELCA "to be an orthodox Lutheran church body." The same resolution also recognized that "many of our brothers and sisters of the ELCA remain faithful to the Gospel of our Lord Jesus Christ" and resolved "to reach out to them in love and support."

It further resolved that "current cooperative pastoral working arrangements with the ELCA be evaluated by the Praesidium (Synod president and vice-presidents) with the results and recommendations reported to the next synodical convention." The report of the Praesdium in response to this resolution is found in the 2004 convention *Workbook*, beginning on page 79.

! Resolution 3-07 of the 2004 convention (complete text—pp. 131-132, 2004 Convention *Proceedings*), in response to the report of the Praesdium, resolved to "authorize the Praesdium to continue to monitor current concerns and potential directions of the ELCA," and that "the President of the Synod report to the next synodical convention any recommendations concerning changes in joint activity with the ELCA." In my report to the 2007 convention regarding this resolution (2007 convention *Proceedings*, p. 63), I stated that "the Praesidium believes

that the President of the LCMS and the Praesdium need to 'continue to assess pastoral working relationships with the ELCA' (2004 Res. 3-07) during the next triennium" and that "at this time there are no recommendations for convention consideration regarding any changes in joint activity with the ELCA."

I went on to state that "the ELCA continues to demonstrate a vastly different understanding of the authority of Holy Scripture and the Lutheran Confessions than does The Lutheran Church—Missouri Synod" and that the reason for continuing theological discussions with the ELCA "is, as articulated in Resolution 3-07, a 'continuing effort to bear witness to the truth of the Scriptures and the Confessions in the hope that agreement can be reached in those areas where we disagree'."

! Resolution 1-11 of the 2007 convention (2007 convention *Proceedings*, p. 114) resolved that "the Praesidium continue to assess the LCMS campus ministries and their association with the ELCA and report to the next convention of the Synod (2010) any suggested changes."

Obviously, no LCMS convention action in response to the actions of this year's ELCA Churchwide Assembly has yet been taken. In accord with the 2004 convention resolution referenced above, the Praesdium will continue in its monitoring role, confident of the Synod members' further pledge in that resolution to "commit ourselves as members of the Synod to walk together in supporting the leadership of the President in consultation with the Praesdium of Synod regarding this relationship between conventions."

Therefore, following consultation with and concurrence from all five Vice-Presidents of the Synod, I'm sharing with you this memo. Pending further action by the Synod in convention, as you approach and engage in joint work with members of the ELCA (such as a social ministry organization, school, campus ministry, chaplaincy, etc.), when matters related to the action of the ELCA Churchwide Assembly arise, please consider and heed the following counsel:

- 1. Evangelically, yet unequivocally, bear witness to the truth of Holy Scripture regarding homosexual behavior.
- 2. Indicate, as I did in my remarks to the ELCA Churchwide Assembly, that the action of the ELCA Churchwide Assembly threatens to deepen the division between our church bodies.
- 3. Communicate that any action taken by the group or organization in which you are participating that is contrary to the position of the LCMS will be taken seriously and will be cause for evaluation of continued LCMS participation in that group or organization.
- 4. Maintain ministry practices that are in accord with Holy Scripture and the Lutheran Confessions and are consistent with the position of The Lutheran Church—Missouri Synod.
- 5. Seek ecclesiastical supervision from the president of the Synod for questions that may arise in case by case situations.

These matters are very serious and need to be handled carefully and evangelically, always endeavoring to speak the truth in love. In the process of so doing, we remain committed to "reach out in love and support" to the "many of our brothers and sisters of the ELCA [who] remain faithful to the Gospel of our Lord Jesus Christ."

You are in my prayers, my brothers in Christ, as you faithfully, responsibly, and lovingly carry out the responsibilities of the office to which you have been elected.

The Grace Crusade
